# **Terms and Conditions** Spinarama July - August 2024 GAMLB09518

The following Promotion Details are to be read in conjunction with the Terms and Conditions.

	Promotion Details
Item 1: Promoter	The Promoter is The Star Entertainment Qld Limited ABN 78 010 741 045 trading as The Treasury Brisbane, 130 William Street, Brisbane City, Queensland 4000, (07) 3306 8888 (the "Promoter").
Item 2: Promotion	Spinarama: July - August 2024 (the "Promotion").
Item 3: Participating Property	Treasury Brisbane
Item 4: Promotion Period	The Promotion will commence at 4.00pm on Tuesday 9 July 2024 and will end at the conclusion of the 6.20pm draw on Thursday 15 August 2024.
	All times are listed in Australian Eastern Standard Time (AEST) unless otherwise specified.
Item 5: Entry Requirement	Participation in the Promotion is open to all persons who satisfy clause 2 of the Terms and Conditions of this Promotion, and who are a Select Members of The Star Club with an active membership card (each an "Eligible Entrant").
Item 6: Entry Period	An Eligible Entrant does not generate or earn entries for this promotion.
	Eligible Entrants simply need to have an open rating (as detailed in <b>Item 7</b> ) at the time of a Random Selection Draw to be eligible to win.

The Promoter cannot guarantee that all announcements can be heard at the Draw Location or in all parts of the Participating Property.

Selected Eligible Entrants that satisfy these terms and conditions will be deemed a "Selected Winner".

### Item 10: Present at Draws

# "Present at the relevant Draw"

Time Extensions or waivers will not be granted retrospectively. If a waiver is granted by the Promoter, the drawn Eligible Entrant must still comply with all instructions required to validate their identity, including but not limited to the conditions set out in Item 13.

	If the drawn Eligible Entrant does not satisfy the above criteria, they will be deemed Not Present at the Relevant Prize Draw and <b>Item 12</b> will apply.
Item 11: Prize/s	Prior to each Random Selection Draw, the MC will spin the Spinarama Prize Wheel and determine the Selected Winners' prize.
	The Selected Winner can choose to take the original prize or spin the Spinarama Prize Wheel to select another prize. If the Selected Winner chooses to spin for a second time, they automatically forfeit the original prize.
	The Spinarama Wheel contains eighteen (18) segments, consisting of:
	<ol> <li>Eight (8) segments of \$250 Casino Dollars</li> <li>Four (4) segments of \$500 Dining Credits</li> <li>Three (3) segments of \$1,000 Dining Credits</li> <li>Two (2) segments of \$1,500</li> <li>One (1) segment of \$2,000</li> </ol>
	The Prize Wheel must make a minimum of two full rotations to deemed a valid spin. Should the Prize Wheel not complete two full rotations, the MC will be required to spin the wheel again.
	If the indicator comes to rest between 2 segments (that is, the indicator stops on a peg), the Prize in the segment that last passed the indicator before it stopped is the Prize awarded to the Selected Winner.
	The total minimum Prize Pool for each draw day is \$2,000 Casino Dollars and the total maximum Prize Pool for each draw day is valued at \$16,000.
	Should the Selected Winner not wish to participate in spinning the Prize Wheel, they will be awarded the original prize which was spun by the MC prior to the Selected Winner being selected.

Item 13: Identification	A Selected Winner must produce Valid ID to a representative of the Promoter to confirm their eligibility to win a prize.

	<ul> <li>a) a passport, Australian driver's licence or other form of photographic identification in which the photograph is clear and undamaged and that is acceptable to The Star Gold Coast; or</li> </ul>
	<ul> <li>two forms of non-photographic identification that are valid and acceptable to The Star Entertainment Group.</li> </ul>
	The Promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of a winner is determinable by a representative of the Promoter without the assistance of these or any other form of identification.

# Item 14: Other conditions

# The Star Club

Any Member found to be in breach of The Star Club Membership terms and conditions of use, including participation or knowledge of fraudulent activity such as purposely participating with another Members Membership Card, is subject to consequences determined by The Promoter and The Star Club terms and conditions. The Promoter reserves the right to review and utilise all property resources available, including security and CCTV footage, if a Member is suspected for fraudulent or undesirable use of a Membership Card that calls into question the validity of any prize won.

### **Dining Credits**

Dining Credit Prizes will load directly to the Members account. These may become unavailable at any time, outside of the control of the Promoter.

Dining Credits will expire if at least one (1) Tier Point is not accrued at least once every 90 days.

## **Casino Dollars**

Casino Dollar Prizes will load directly to the Members account. Casino Dollars may become unavailable at any time, outside of the control of the Promoter.

Casino Dollars will expire if at least one (1) Tier Point is not accrued at least once every 180 days.

# No substitutions, transfers, replacement or gift receipts/exchanges

Prizes cannot be substituted and are not transferrable.

#### **Terms and Conditions**

- The Promoter listed in Item 1 will conduct the Promotion listed in Item 2 at the Participating Property listed in Item 3 during the Promotion Period listed in Item 4.
- Participation in the Promotion is open to all persons who meet and continue to satisfy throughout the Promotion Period the details listed in Item 5 as well as the following requirements:
  - a. 18 years of age or older;
  - b. entitled to access the Draw Location;
  - not excluded (including an exclusion direction or self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); and

- 3. If an Eligible Entrant: (i) has their membership status cancelled or otherwise amended; (ii) is excluded from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); or (iii) is issued a Withdrawal of License (WOL) from The Star Sydney, The Star Gold Coast or Treasury Brisbane:

- Conduct of the entire Promotion, including decisions on the eligibility of persons to enter and validity of entry and prizes, shall be the responsibility of the Promoter.
- 11. To the extent that a situation or issue arises for which these Terms and Conditions make no provision for or a situation or issue arises to which the relevant Terms and Conditions are unclear, the Promoter reserves the right to make a decision regarding such situation or issue which is not inconsistent with these Terms and Conditions.
- 12. The Promoter accepts no responsibility for late or non-received Entry/Entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Promotion.
- 13. In the event that a malfunction occurs with Synkros system, the Promoter will extract from the Synkros system all virtual entries earned in accordance with these Terms and Conditions and the draw process will be conducted manually.
- 14. The Promoter reserves the right to waive or vary the identification requirements specified in these Terms and Conditions in circumstances where the identity of the winner is determinable without the assistance of the specified identification.
- 15. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
