The following Promotion Details are to be read in conjunction with the Terms and Conditions.

Promotion Details	
Item 1: Promoter	The Promoter is The Star Entertainment Qld Limited ABN 78 010 741 045 trading as The Treasury Brisbane, 130 William Street, Brisbane City, Queensland 4000, (07) 3306 8888 (the "Promoter").
Item 2: Promotion	Spinarama: July - August 2024 (the "Promotion").
Item 3: Participating Property	Treasury Brisbane
Item 4: Promotion Period	The Promotion will commence at 4.00pm on Tuesday 9 July 2024 and will end at the conclusion of the 6.20pm draw on Thursday 15 August 2024. All times are listed in Australian Eastern Standard Time (AEST) unless otherwise specified.
Item 5: Entry Requirement	Participation in the Promotion is open to all persons who satisfy clause 2 of the Terms and Conditions of this Promotion, and who are a Select Members of The Star Club with an active membership card (each an "Eligible Entrant").
Item 6: Entry Period	An Eligible Entrant does not generate or earn entries for this promotion. Eligible Entrants simply need to have an open rating (as detailed in Item 7) at the time of a Random Selection Draw to be eligible to win.
Item 7: Method of Entry	During the Promotion Period, Eligible Entrants can enter the Random Selection Draws by having an open rating and playing on any compatible electronic gaming machines, compatible electronic table game (each an "Eligible Machine") or compatible table game (each an "Eligible Table"), excluding Treasury Brisbane Tournament Omaha or Texas Hold'em Poker, on the Ground or Main Gaming Floors at Treasury Brisbane, at the time of a Random Selection Draw. To be deemed to be 'playing an Eligible Machine', an Eligible Entrant must be actively playing at the Eligible Machine and have their Membership Card inserted and credit available at the time the Konami Casino Management System recognises the "Random Selection Draw". To be deemed to be 'playing an Eligible Table', an Eligible Member must be seated at the Eligible Table Game and have handed their Membership Card to the dealer and have an open rating at the moment the Konami Casino Management System recognises the "Random Selection Draw".

The Promoter cannot guarantee that all announcements can be heard at the Draw Location or in all parts of the Participating Property.</p> <p>Selected Eligible Entrants that satisfy these terms and conditions will be deemed a “Selected Winner”.</p>
Item 9: Draw Location	The Main Gaming Floor – Treasury Brisbane
Item 10: Present at Draws	<p><u>“Present at the relevant Draw”</u></p> <p>To be eligible to claim a Prize, drawn Eligible Entrants must present themselves to a representative of the Promotor at any Customer Services Desk or to the Draw Location within three (3) minutes of their name being announced and provide suitable identification.</p> <p>If a drawn Eligible Entrant has presented themselves to a representative of the Promoter, the representative will inform the promotions host at the Draw Location that the drawn Eligible Entrant has presented themselves and the drawn Eligible Entrant will have ten (10) minutes to make their way to the Draw Location and confirm their identity. The drawn Eligible Entrant is not permitted to send a proxy to claim a prize.</p> <p>Provided that the Eligible Entrant is at the Participating Property, the Promoter reserves the right, in its absolute discretion, to either:</p> <ul style="list-style-type: none"> • extend the time limit set out in this clause for the Eligible Entrant to make their way to the Draw Location; or • waive the requirement for the Eligible Entrant to present themselves at the Draw Location, <p>if the Promoter forms the reasonable view that the relevant drawn Eligible Entrant will be physically unable to comply with such time limit or requirement due to incapacity or any other such impairment.</p> <p>It is the responsibility of the drawn Eligible Entrant to request such time extension or waiver from the representative of the Promoter immediately on presenting themselves to the representative of the Promoter. Time Extensions or waivers will not be granted retrospectively. If a waiver is granted by the Promoter, the drawn Eligible Entrant must still comply with all instructions required to validate their identity, including but not limited to the conditions set out in Item 13.</p>

	<p>If the drawn Eligible Entrant does not satisfy the above criteria, they will be deemed Not Present at the Relevant Prize Draw and Item 12 will apply.</p>
<p>Item 11: Prize/s</p>	<p>Prior to each Random Selection Draw, the MC will spin the Spinarama Prize Wheel and determine the Selected Winners' prize.</p> <p>The Selected Winner can choose to take the original prize or spin the Spinarama Prize Wheel to select another prize. If the Selected Winner chooses to spin for a second time, they automatically forfeit the original prize.</p> <p>The Spinarama Wheel contains eighteen (18) segments, consisting of:</p> <ol style="list-style-type: none"> 1. Eight (8) segments of \$250 Casino Dollars 2. Four (4) segments of \$500 Dining Credits 3. Three (3) segments of \$1,000 Dining Credits 4. Two (2) segments of \$1,500 5. One (1) segment of \$2,000 <p>The Prize Wheel must make a minimum of two full rotations to be deemed a valid spin. Should the Prize Wheel not complete two full rotations, the MC will be required to spin the wheel again.</p> <p>If the indicator comes to rest between 2 segments (that is, the indicator stops on a peg), the Prize in the segment that last passed the indicator before it stopped is the Prize awarded to the Selected Winner.</p> <p>The total minimum Prize Pool for each draw day is \$2,000 Casino Dollars and the total maximum Prize Pool for each draw day is valued at \$16,000.</p> <p>Should the Selected Winner not wish to participate in spinning the Prize Wheel, they will be awarded the original prize which was spun by the MC prior to the Selected Winner being selected.</p> <p>A Selected Winner can only win one (1) Prize per Draw Day. <p>Item 12: Redraw/s</p>	<p><u>"Not present at the relevant Draw"</u></p> <p>If the drawn Eligible Entrant does not present to the draw location within the time limit listed in Item 10 or does not otherwise satisfy these Terms and Conditions, redraws will take place until an Eligible Entrant who satisfies the requirements of these Terms and Conditions is identified.</p>
<p>Item 13: Identification</p>	<p>A Selected Winner must produce Valid ID to a representative of the Promoter to confirm their eligibility to win a prize.</p> <p>"Valid ID" means:</p> <ol style="list-style-type: none"> a) a passport, Australian driver's licence or other form of photographic identification in which the photograph is clear and undamaged and that is acceptable to The Star Gold Coast; or b) two forms of non-photographic identification that are valid and acceptable to The Star Entertainment Group. <p>The Promoter reserves the right to waive or vary the identification requirements at its sole discretion in circumstances where the identity of a winner is determinable by a representative of the Promoter without the assistance of these or any other form of identification.</p>

<p>Item 14: Other conditions</p>	<p><u>The Star Club</u> Any Member found to be in breach of The Star Club Membership terms and conditions of use, including participation or knowledge of fraudulent activity such as purposely participating with another Members Membership Card, is subject to consequences determined by The Promoter and The Star Club terms and conditions. The Promoter reserves the right to review and utilise all property resources available, including security and CCTV footage, if a Member is suspected for fraudulent or undesirable use of a Membership Card that calls into question the validity of any prize won.</p> <p><u>Dining Credits</u> Dining Credit Prizes will load directly to the Members account. These may become unavailable at any time, outside of the control of the Promoter.</p> <p>Dining Credits will expire if at least one (1) Tier Point is not accrued at least once every 90 days.</p> <p><u>Casino Dollars</u> Casino Dollar Prizes will load directly to the Members account. Casino Dollars may become unavailable at any time, outside of the control of the Promoter.</p> <p>Casino Dollars will expire if at least one (1) Tier Point is not accrued at least once every 180 days.</p> <p><u>No substitutions, transfers, replacement or gift receipts/exchanges</u> Prizes cannot be substituted and are not transferrable.</p>

Terms and Conditions

1. The Promoter listed in **Item 1** will conduct the Promotion listed in **Item 2** at the Participating Property listed in **Item 3** during the Promotion Period listed in **Item 4**.
2. Participation in the Promotion is open to all persons who meet and continue to satisfy throughout the Promotion Period the details listed in Item 5 as well as the following requirements:
 - a. 18 years of age or older;
 - b. entitled to access the Draw Location;
 - c. not excluded (including an exclusion direction or self-exclusion order) from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); and
 - d. not the subject of a Withdrawal of License (**WOL**) from The Star Sydney, The Star Gold Coast or Treasury Brisbane.
3. If an Eligible Entrant: (i) has their membership status cancelled or otherwise amended; (ii) is excluded from a casino or premises operated by The Star Entertainment Group Limited (and its related entities); or (iii) is issued a Withdrawal of License (**WOL**) from The Star Sydney, The Star Gold Coast or Treasury Brisbane:
 - (a) during the Promotion; or
 - (b) prior to that person claiming the relevant prize (if the Eligible Entrant is a selected winner),

so that he or she no longer satisfies **Condition 2**, that person will no longer be eligible to enter or participate in the Promotion and/or claim a prize

Directors, management, and employees of The Star Entertainment Group of companies (including any related body corporate as defined in the *Corporations Act 2001*) and their immediate families are not eligible to participate in this Promotion. For the purposes of this clause, 'immediate families' of an employee means the person's spouse and family members residing at the same premises as the employee. The Star Entertainment Group comprises but is not limited to the businesses of The Star

Sydney, The Star Gold Coast and Treasury Brisbane.

10. Conduct of the entire Promotion, including decisions on the eligibility of persons to enter and validity of entry and prizes, shall be the responsibility of the Promoter.
11. To the extent that a situation or issue arises for which these Terms and Conditions make no provision for or a situation or issue arises to which the relevant Terms and Conditions are unclear, the Promoter reserves the right to make a decision regarding such situation or issue which is not inconsistent with these Terms and Conditions.
12. The Promoter accepts no responsibility for late or non-received Entry/Entries. The Promoter does not guarantee the continuous or fault-free operation of the entry processes, including entry validating and receipting processes, during the Promotion.
13. In the event that a malfunction occurs with Synkros system, the Promoter will extract from the Synkros system all virtual entries earned in accordance with these Terms and Conditions and the draw process will be conducted manually.
14. The Promoter reserves the right to waive or vary the identification requirements specified in these Terms and Conditions in circumstances where the identity of the winner is determinable without the assistance of the specified identification.
15. Any entrant who tampers, or attempts to tamper, with the entry processes or tampers, or attempts to tamper with the processes used for the draws or who submits an entry which is not valid in accordance with these terms will be subject to disqualification at the discretion of the Promoter.
16. Entrants may be asked to participate in publicity or advertising at the request of the Promoter. Participation in any such publicity or advertising is at the sole discretion of the relevant Entrant. The names of Entrants will not be published without their consent except as announced at the Draw Location.
17. The Star Gold Coast reserves the right to cancel or change any Prize offered under the Promotion if there are any changes to the law which would or might render the Promotion or any prizes offered under the Promotion unlawful.

If this Promotion cannot run as planned for any reason beyond the Promoter's control, for example due to software, hardware or communications issues, unauthorised intervention, tampering, fraud or technical failure, the Promoter may end, change, suspend or cancel the Promotion or disqualify affected entries/entrants
